

**FACTS****WHAT DOES CAR LOANS INC  
DO WITH YOUR PERSONAL INFORMATION?**

<b>Why?</b>	Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.
<b>What?</b>	<p>The types of personal information we collect and share depend on the product or service you have with us. This information can include:</p> <ul style="list-style-type: none"> <li>■ Social Security number and employment information</li> <li>■ Account balances and transaction history</li> <li>■ Credit balances and credit scores</li> </ul> <p>When you are <i>no longer</i> our customer, we continue to share your information as described in this notice.</p>
<b>How?</b>	All financial companies need to share <b>customers'</b> personal information to run their everyday business. In the section below, we list the reasons financial companies can share their <b>customers'</b> personal information; the reasons Car Loans Inc chooses to share; and whether you can limit this sharing.

### How does Car Loans Inc collect my personal information?

We collect your personal information, for example, when you

- Make a payment or perform transactions
- Apply for a loan or provide employment information
- Provide us with your contact information

We collect your personal information from others, such as credit bureaus, affiliates and other companies

### Why can't I limit all sharing?

Federal law gives you the right to limit only

- sharing for affiliates' everyday business purposes—information about your creditworthiness
- affiliates from using your information to market to you
- sharing for nonaffiliates to market to you

State laws and individual companies may give you additional rights to limit sharing.

## Definitions

### Affiliates

Companies related by common ownership or control. They can be financial and nonfinancial companies.

- *Our affiliates include our parent company Car Loans Inc, Car Loans Nevada LLC, Car Loans Utah LLC and Car Loans Idaho LLC*

### Nonaffiliates

Companies not related by common ownership or control. They can be financial and nonfinancial companies.

- *Car Loans Inc does not share with non-affiliates so they can market to you.*

### Joint marketing

A formal agreement between nonaffiliated financial companies that together market financial products or services to you.

- *Car Loans Inc does not engage in joint marketing with non-affiliated financial companies.*
